

## **PACIFIC WEST MALAYSIA**

### *RAYA UNWIND WITH PACIFIC WEST*

#### **Terms and Conditions:**

1. The Pacific West Malaysia “Raya Unwind with Pacific West” contest (“Contest”) is organised by Pacific West Foods (M) Sdn Bhd (“Organiser”).
2. This Contest shall commence from 1<sup>st</sup> April 2022 till 31<sup>st</sup> May 2022 (“Contest Period”).
3. The Organiser reserves the right to modify, postpone, re-schedule and/or extend the Contest Period and/or cancel/terminate the Contest at any time without giving prior notice.
4. This Contest is open to all citizens and permanent residents of Malaysia, currently residing in Malaysia, aged 18 years old and above with a valid National Registration Identification Card (NRIC) number (12-digits) at the time of participation of the Contest. (“Participants”)
5. The representatives, employees, servants and/or agents of the Organiser (including their respective affiliated and associate companies) and their immediate family members are not eligible to participate in this Contest.
6. The Organiser reserves the right to exclude and/or disqualify Participants who do not fall within the category of Participants and/or who are in breach of the Contest Rules and Regulations.
7. Contest eligibility: To qualify for the Contest, Participants are required to purchase minimum RM35 and above worth of Pacific West products (excluding the “Subi” & “Pacific Greens” brand) in a single official printed receipt during the Contest period.

10. All complete entry forms received by the Organiser during the Contest period if approved by the Organiser, will be serialised according to the POP Table based on the POP submitted [each a “Qualified Entry” and collectively the “Qualified Entries”].
